




Figure 1. Max. Average Forward Current vs.
Ambient Temperature




Figure 2. Typ. Forward Current vs. Forward Voltage




Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles




Figure 4. Typ. Diode Capacitance vs. Reverse Voltage





Figure 5. Typ. Reverse Current vs. Percent of Rated Peak Reverse Voltage

#### **Ozone Depleting Substances Policy Statement**

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.
- 2. Regularly and continuously improve the performance of our products, processes, distribution and operating systems with respect to their impact on the health and safety of our employees and the public, as well as their impact on the environment.

- 2. Class I and II ozone depleting substances in the Clean Air Act Amendments of 1990 by the Environmental Protection Agency (EPA) in the USA
- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

**Vishay Semiconductor GmbH** can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
