




Transmissive Optical Sensor with Phototransistor Output

Description

This device has a compact construction where the emittig-light sources and the detectors are located face-to-face on the same optical axis. The operating wavelength is 950 nm. The detector consists of a phototransistor.


Applications

- Position sensor for shaft encoder
- Detection of opaque material such as paper, IBM cards, magnetic tapes etc.
- Limit switch for mechanical motions in VCR
- Read/ write head position in data storage equipment
- General purpose wherever the space is limited




Figure 1. Test circuit




Figure 2. Switching times




Figure 3. Total Power Dissipation vs.
Ambient Temperature




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Relative Current Transfer Ratio vs.
Ambient Temperature




Figure 6. Collector Dark Current vs. Ambient Temperature




Figure 7. Collector Current vs. Forward Current




Figure 8. Collector Current vs. Collector Emitter Voltage








Figure 9. Current Transfer Ratio vs. Forward Current




Figure 11. Relative Collector Current vs. Displacement





Figure 10. Turn on / off Time vs. Collector Current
