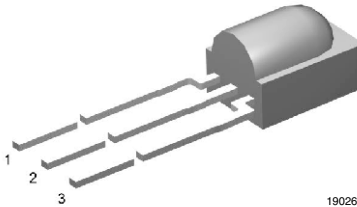

DESCRIPTION

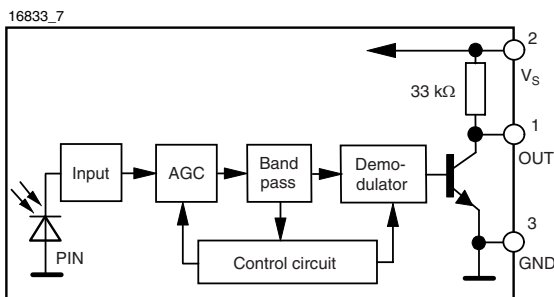
The TSOP592.. series are miniaturized receivers for infrared remote control systems. A PIN diode and a preamplifier are assembled on a lead frame, the epoxy package acts as an IR filter.

The demodulated output signal can be directly decoded by a microprocessor. The TSOP592.. is compatible with all common IR remote control data formats.

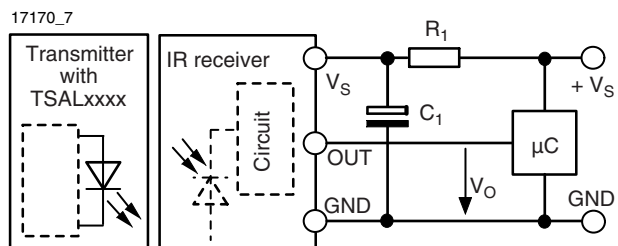

APPLICATION CIRCUIT



The external components R_1 and C_1 are optional to improve the robustness against electrical overstress (typical values are $R_1 = 100 \Omega$, $C_1 = 0.1 \mu\text{F}$).

The output voltage V_O should not be pulled down to a level below 1 V by the external circuit.

The capacitive load at the output should be less than 2 nF.

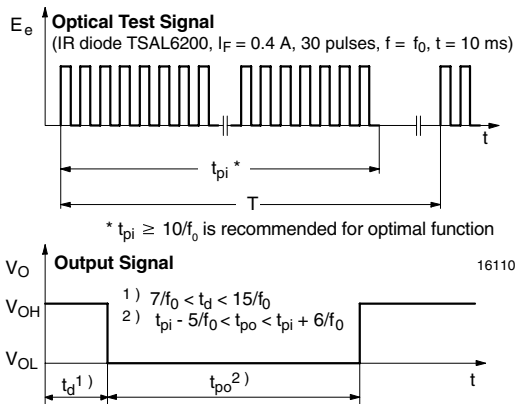


Fig. 1 - Output Active Low

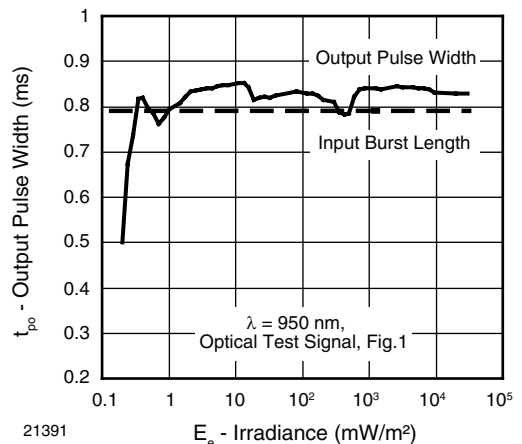


Fig. 2 - Pulse Length and Sensitivity in Dark Ambient

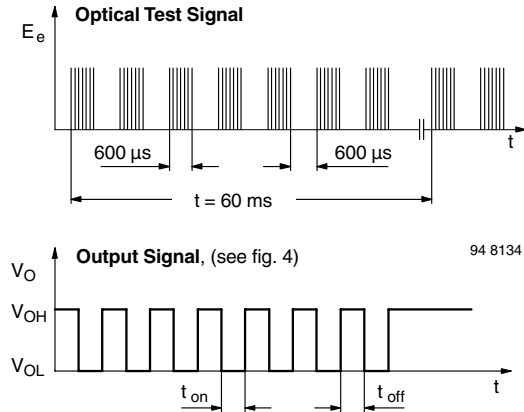
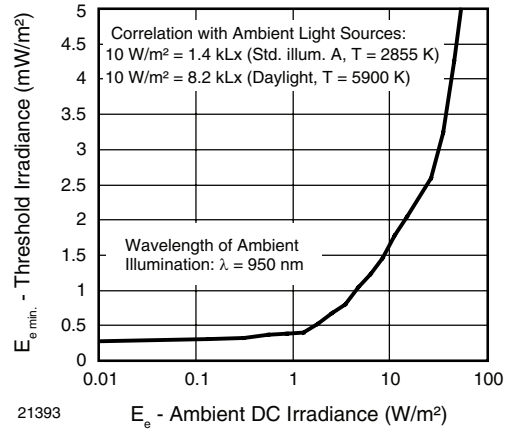
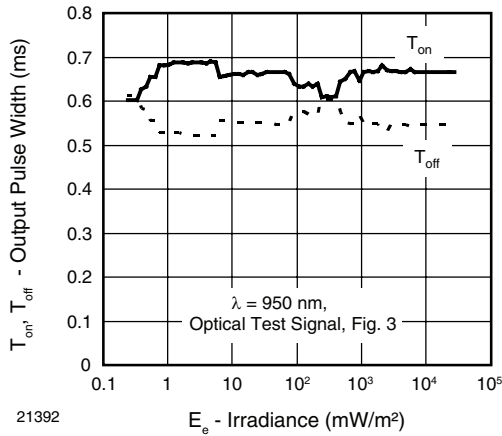


Fig. 3 - Output Function



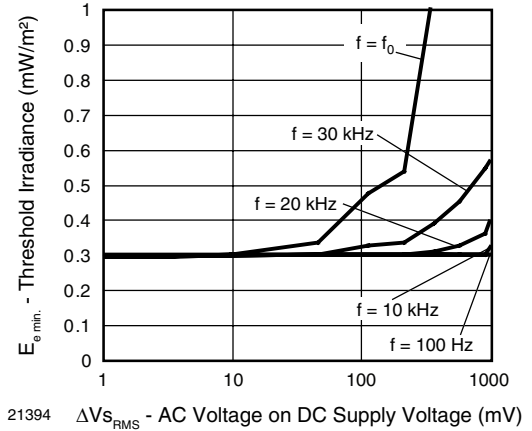

Fig. 6 - Sensitivity in Bright Ambient



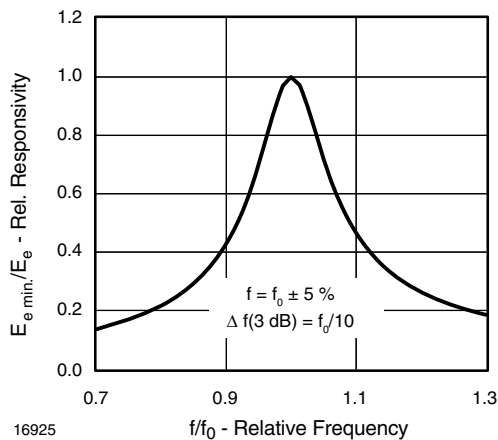

Fig. 4 - Output Pulse Diagram



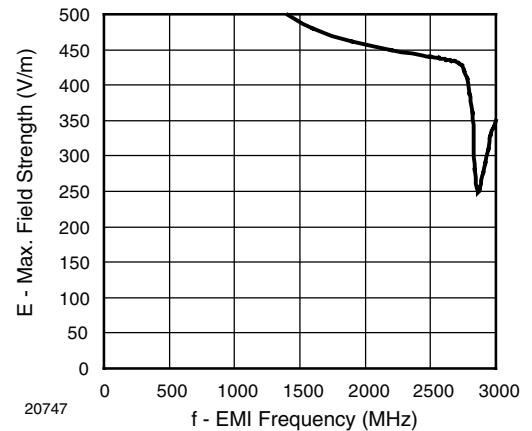

Fig. 7 - Sensitivity vs. Supply Voltage Disturbances



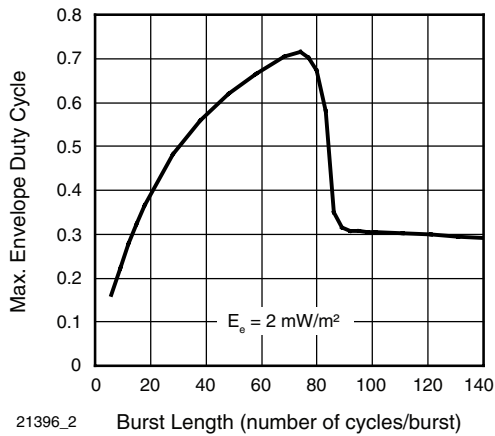

Fig. 5 - Frequency Dependence of Responsivity

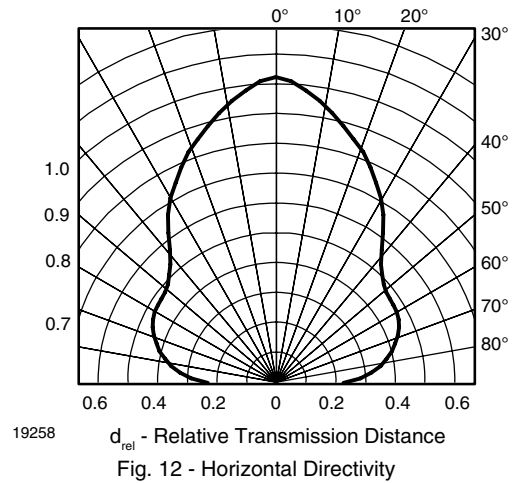

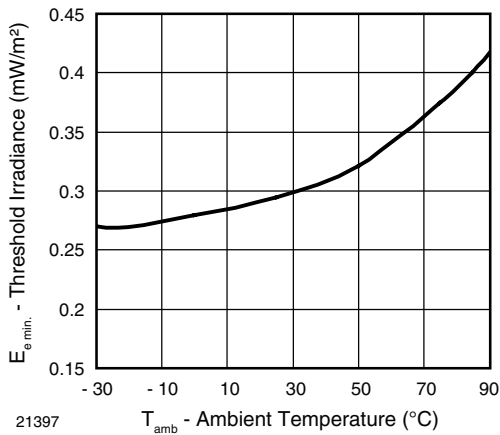
Fig. 8 - Sensitivity vs. Electric Field Disturbances



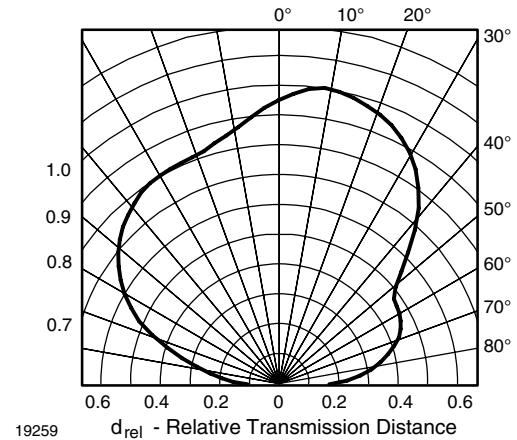

Fig. 9 - Max. Envelope Duty Cycle vs. Burst Length



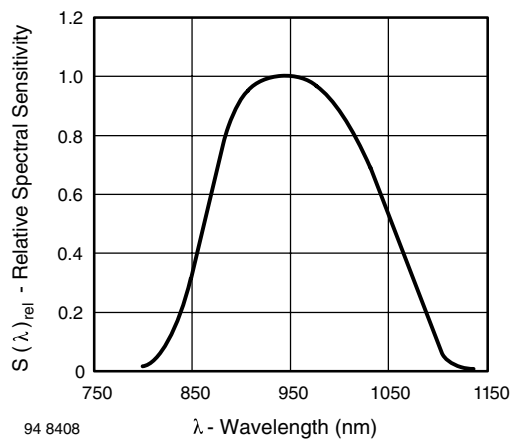

Fig. 12 - Horizontal Directivity



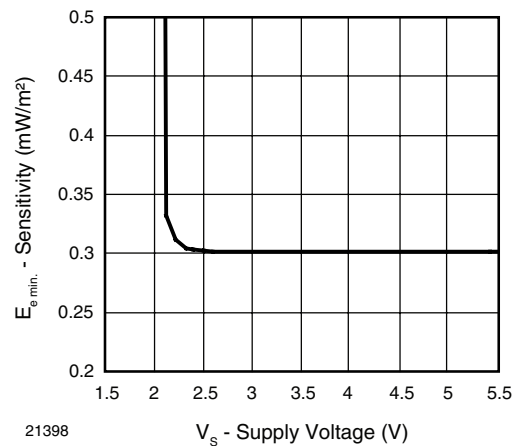

SUITABLE DATA FORMAT

The TSOP592.. series is designed to suppress spurious output pulses due to noise or disturbance signals. Data and disturbance signals can be distinguished by the devices according to carrier frequency, burst length and envelope duty cycle. The data signal should be close to the band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the TSOP592.. in the presence of a disturbance signal, the sensitivity of the receiver is reduced to insure that no spurious pulses are present at the output. Some examples of disturbance signals which are suppressed are:

- DC light (e.g. from tungsten bulb or sunlight)
- Continuous signals at any frequency

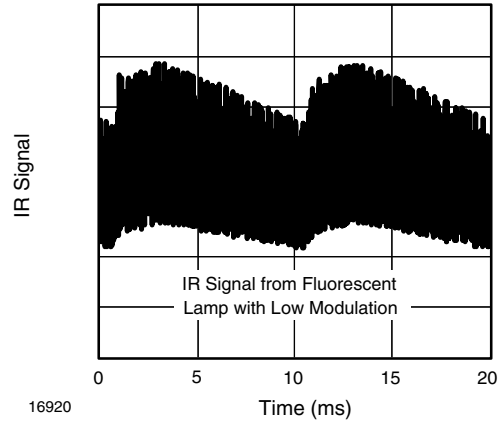


Fig. 15 - IR Signal from Fluorescent Lamp with Low Modulation

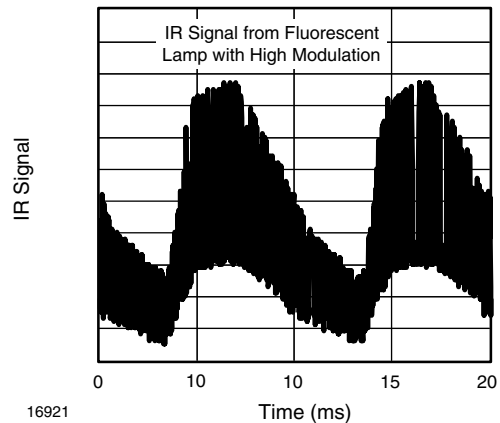


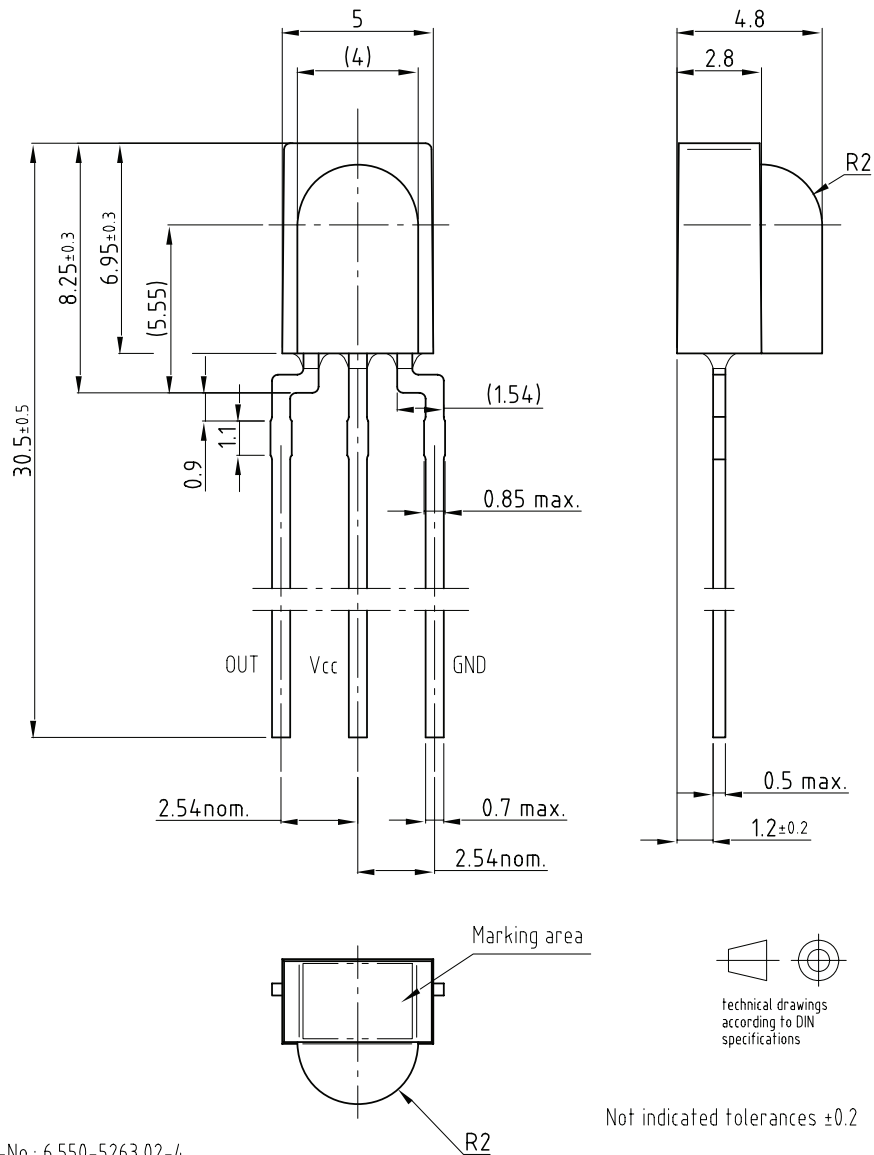
Fig. 16 - IR Signal from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated noise from fluorescent lamps with electronic ballasts (see figure 15 or figure 16)
