DESCRIPTION

The μ PG2045TQ is an L-band SP3T GaAs FET switch which was developed for CDMA/PCS/GPS triple mode digital cellular telephone application. The device can operate from 500 MHz to 2.0 GHz, having the low insertion loss and high linearity by 2.4 V low control voltage.

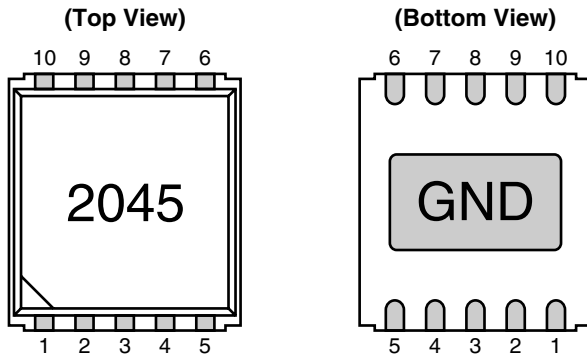

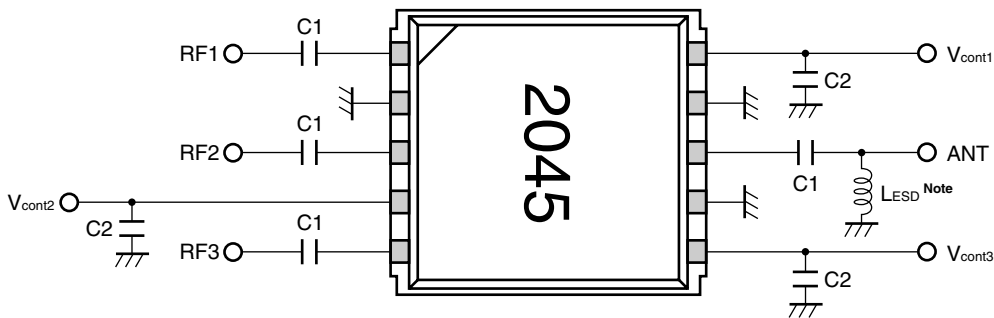

EVALUATION CIRCUIT



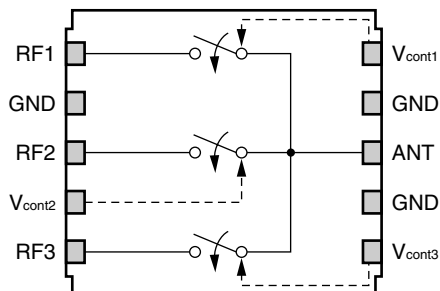

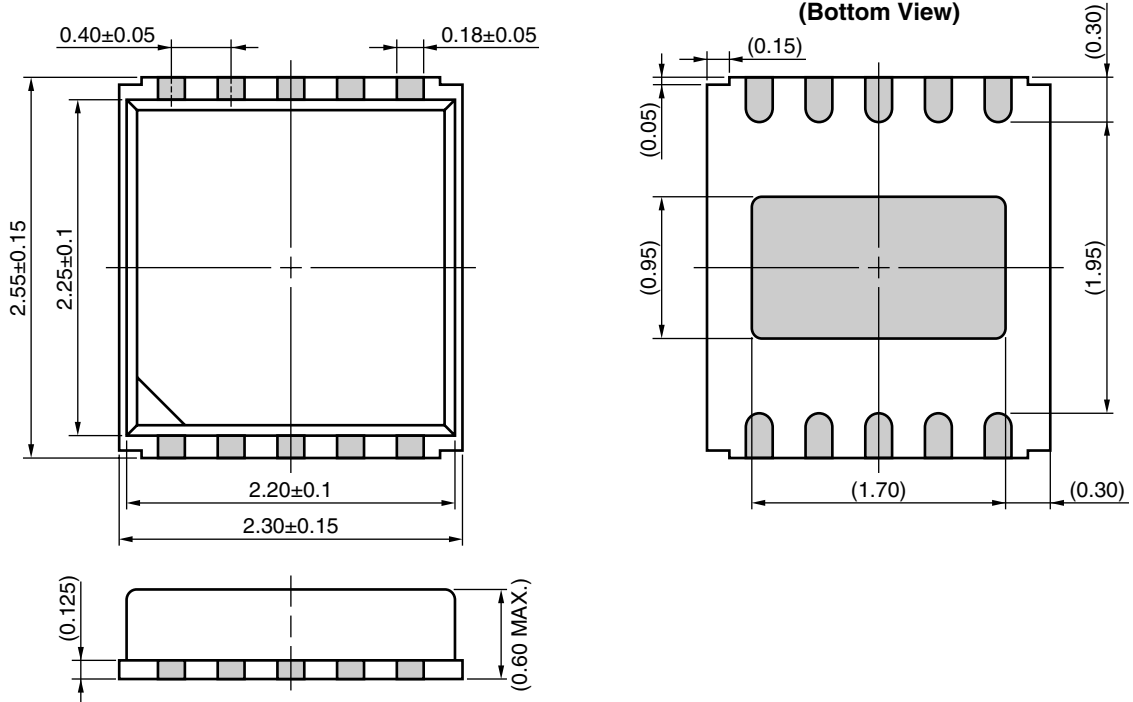
