

Dimensions of S503T in mm









Dimensions of S503TR in mm











Dimensions of S503TRW in mm

Ozone Depleting Substances Policy Statement

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
