


Figure 1. Input Characteristics




Figure 3. Transistor Output Current vs. Voltage




Figure 2. Transistor Current vs. Voltage




Figure 4.  $I_{CEO}$  at  $V_{CE}$  = 10 V vs. Temperature




Figure 5. Normalized CTR vs. Forward Current




Figure 8.  $t_{\text{fall}}$  vs. Forward Current




Figure 6. t<sub>r</sub> vs. Forward Current




Figure 9. t<sub>on</sub> vs. Forward Current




Figure 7. Saturated Switching Characteristics Measurements-Schematic and Waveform




Figure 10.  $t_{\rm off}$  vs. Forward Current






Figure 11. t<sub>phl</sub> vs. Forward Current






Figure 12. t<sub>plh</sub> vs. Forward Current


