






Top View

Equivalent Circuit








 ${}^{-}V_{_{DS}}$ Drain-Source Voltage (V) **P-channel Safe Operating Area**











Gate-Source Voltage v Gate Charge




Basic gate charge waveform



Gate charge test circuit




Switching time waveforms



Switching time test circuit


