8. Packing Specifications

8-1. Moisture-proof Packing

8-2. Storage


9-1. Soldering

(1) Lead free soldering

1) Following soldering paste is recommended Melting temperature: $216 \sim 220$ C. Composition: Sn / 3.5Ag / 0.75Cu




