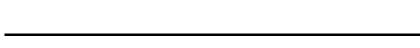




### TYPICAL CHARACTERISTICS (TA = +25°C, unless otherwise specified)

### TOTAL POWER DISSIPATION vs. AMBIENT TEMPERATURE




Ambient Temperature TA (°C)

### COLLECTOR CURRENT vs. BASE TO EMITTER VOLTAGE




Base to Emitter Voltage VBE (V)

## DC CURRENT GAIN vs. COLLECTOR CURRENT




REVERSE TRANSFER CAPACITANCE vs. COLLECTOR TO BASE VOLTAGE




Collector to Base Voltage VcB (V)

Collector to Emitter Voltage  $\ V_{\text{CE}} \ (V)$ 


## GAIN BANDWIDTH PRODUCT vs. COLLECTOR CURRENT




Collector Current Ic (mA)


