









Figure 6 On-Resistance Variation with Temperature












Figure 8 Gate Threshold Variation vs. Ambient Temperature




Figure 10 Typical Drain-Source Leakage Current vs. Voltage




Figure 12 Gate-Charge Characteristics







Figure 13 Transient Thermal Resistance




V_{DS}, DRAIN-SOURCE VOLTAGE (V) Figure 14 SOA, Safe Operation Area


