
□INSERTION LOSS

RETURN LOSS



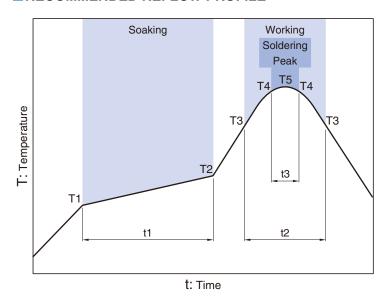
