



## **Typical Inductance vs. Current Characteristics:**




## **Typical Inductance vs. Frequency Characteristics:**







# **Q-Factor vs. Frequency:**




# **Typical Temperature Rise vs. Current Characteristics:**

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.


Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.
