10-bit bus switch with 5-bit output enables

Rev. 3 — 11 November 2016

## 1. General description

---

The 74CBTLV3384 is a dual 5-pole, single-throw bus switch. The device features two output enable inputs ( $\overline{nOE}$ ) that each control five switch channels. The switches are disabled when the associated  $\overline{nOE}$  input is HIGH. Schmitt-trigger action at control inputs makes the circuit tolerant of slower input rise and fall times. This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

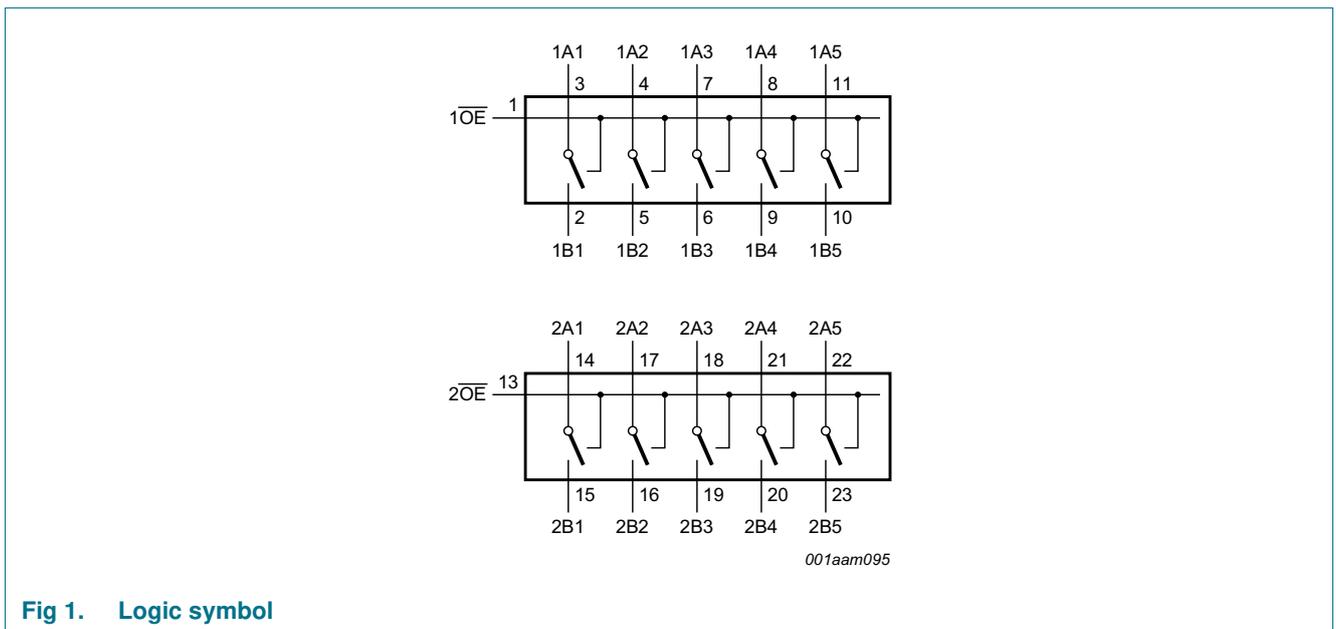


Fig 1. Logic symbol

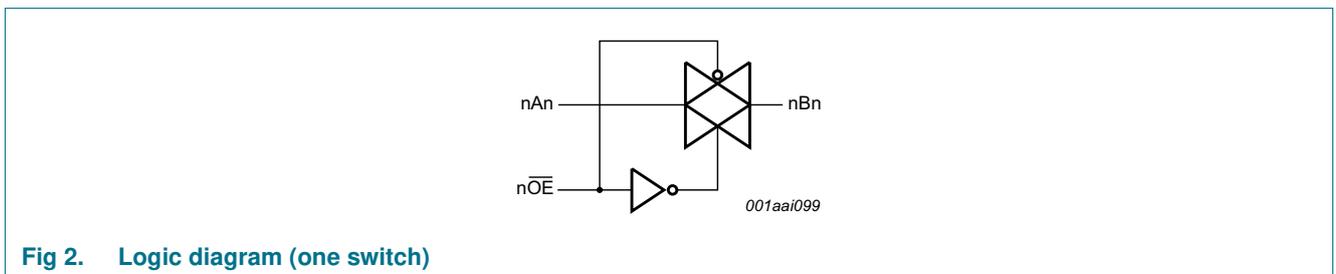
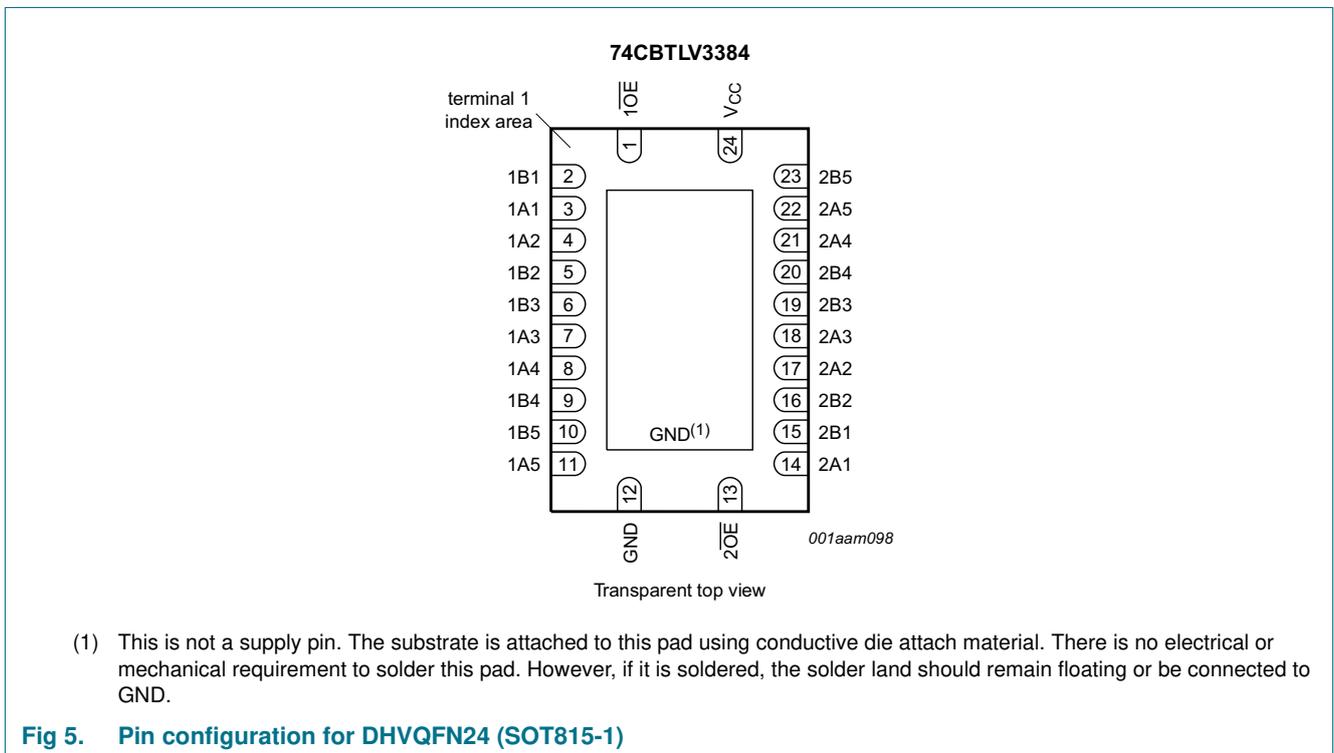
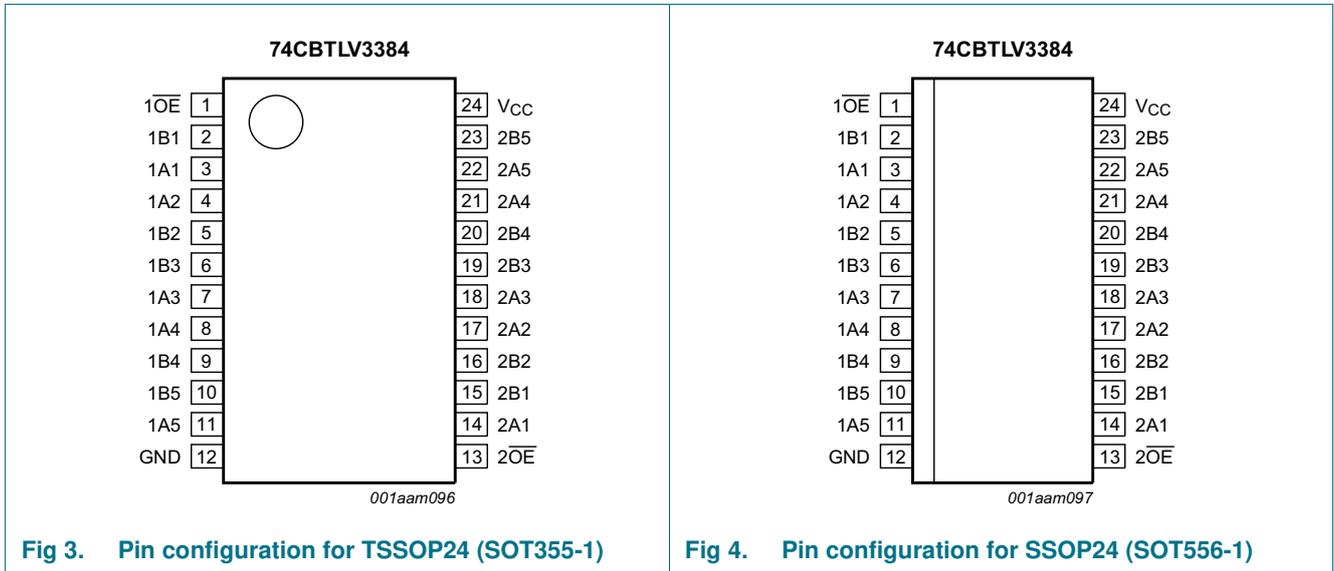


Fig 2. Logic diagram (one switch)

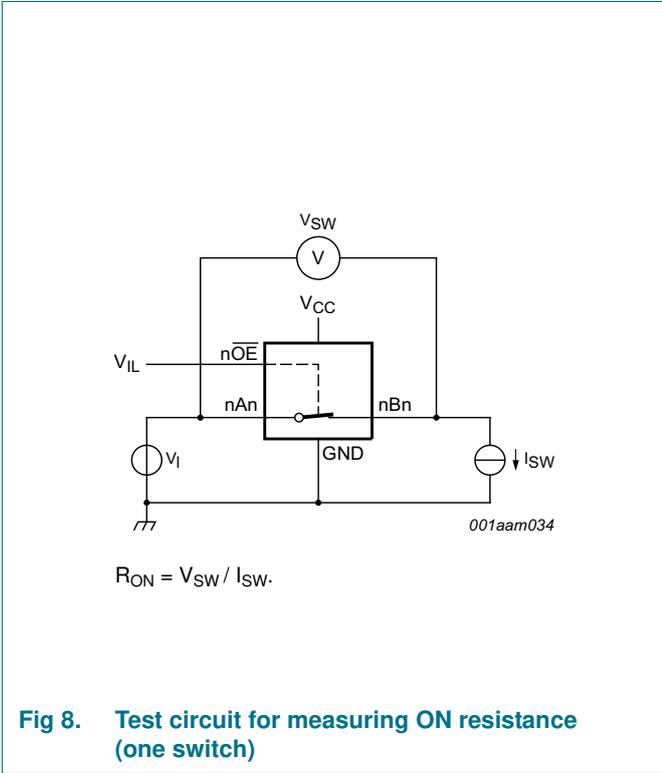
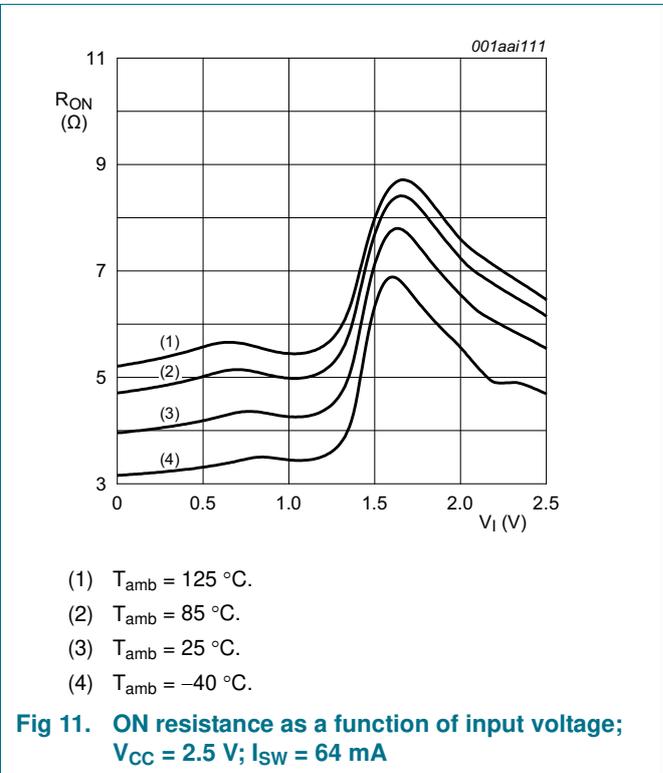
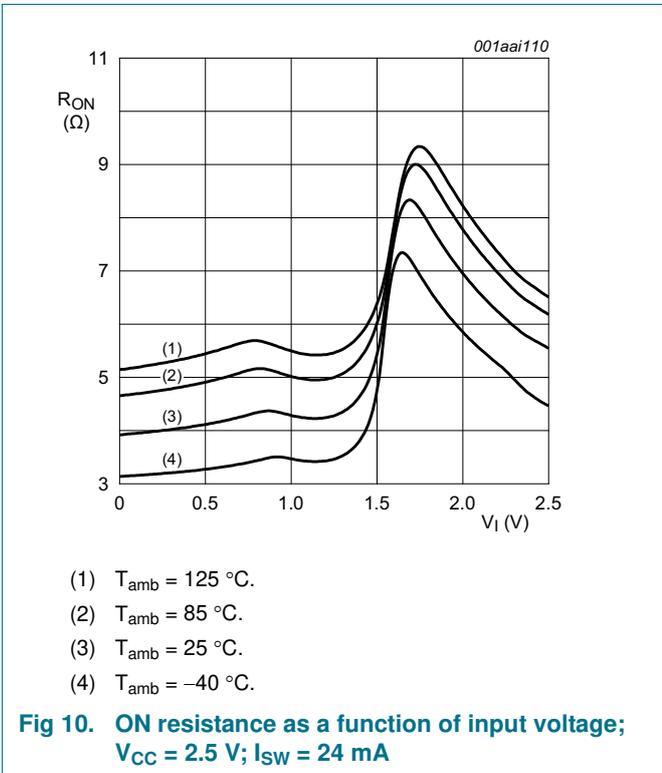
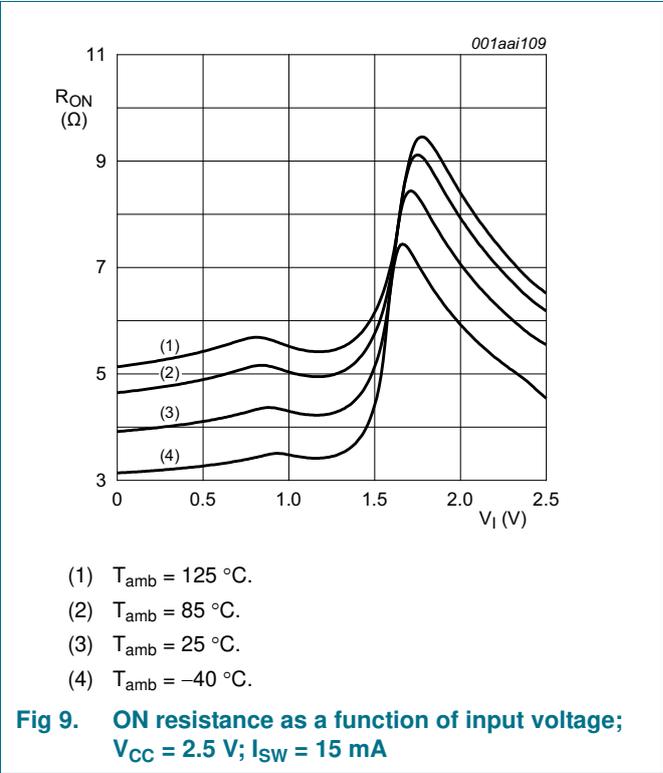
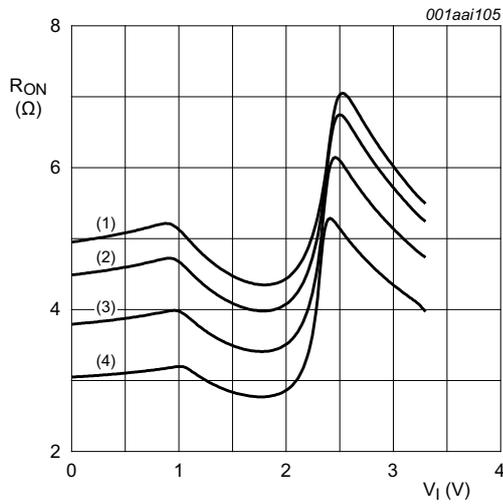


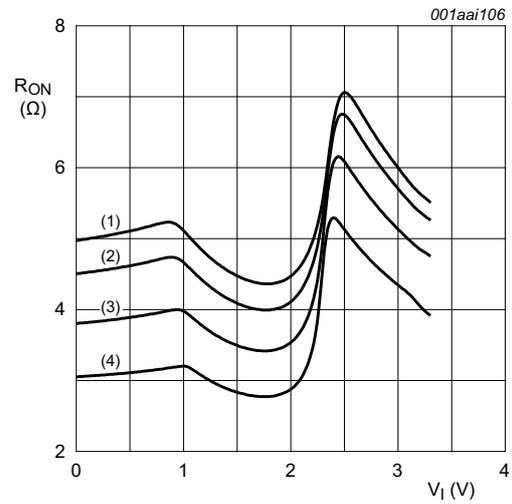
Fig 8. Test circuit for measuring ON resistance (one switch)





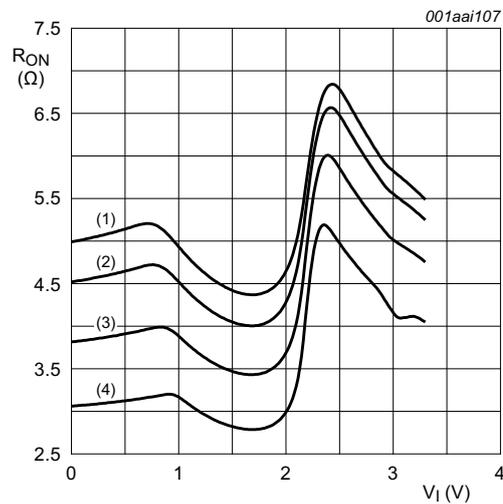

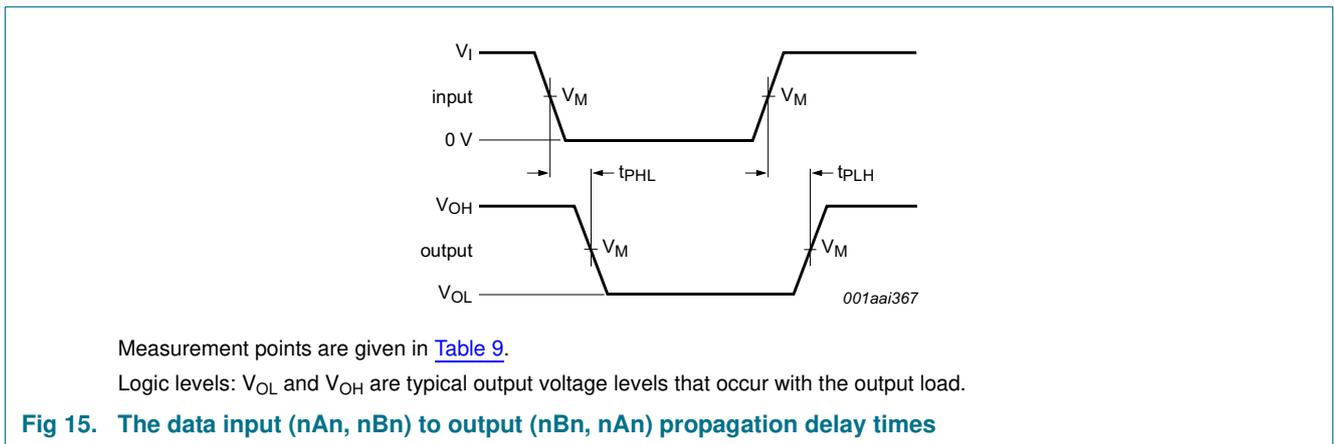

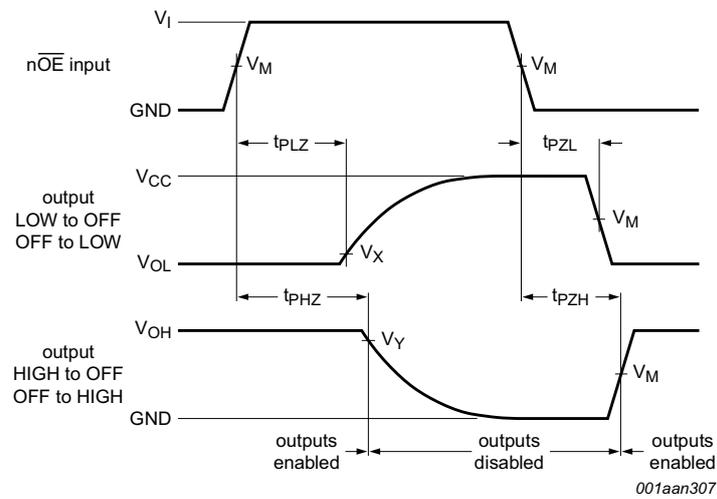

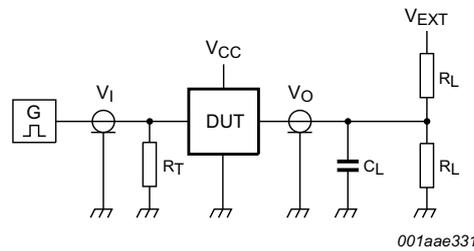
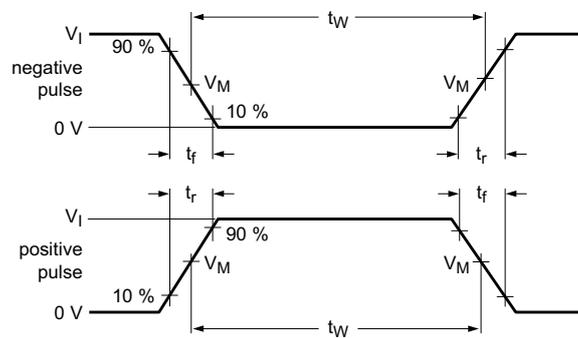

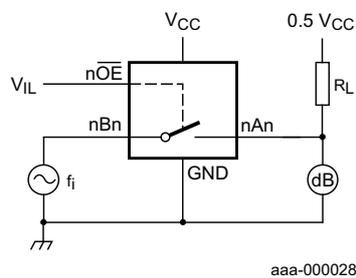

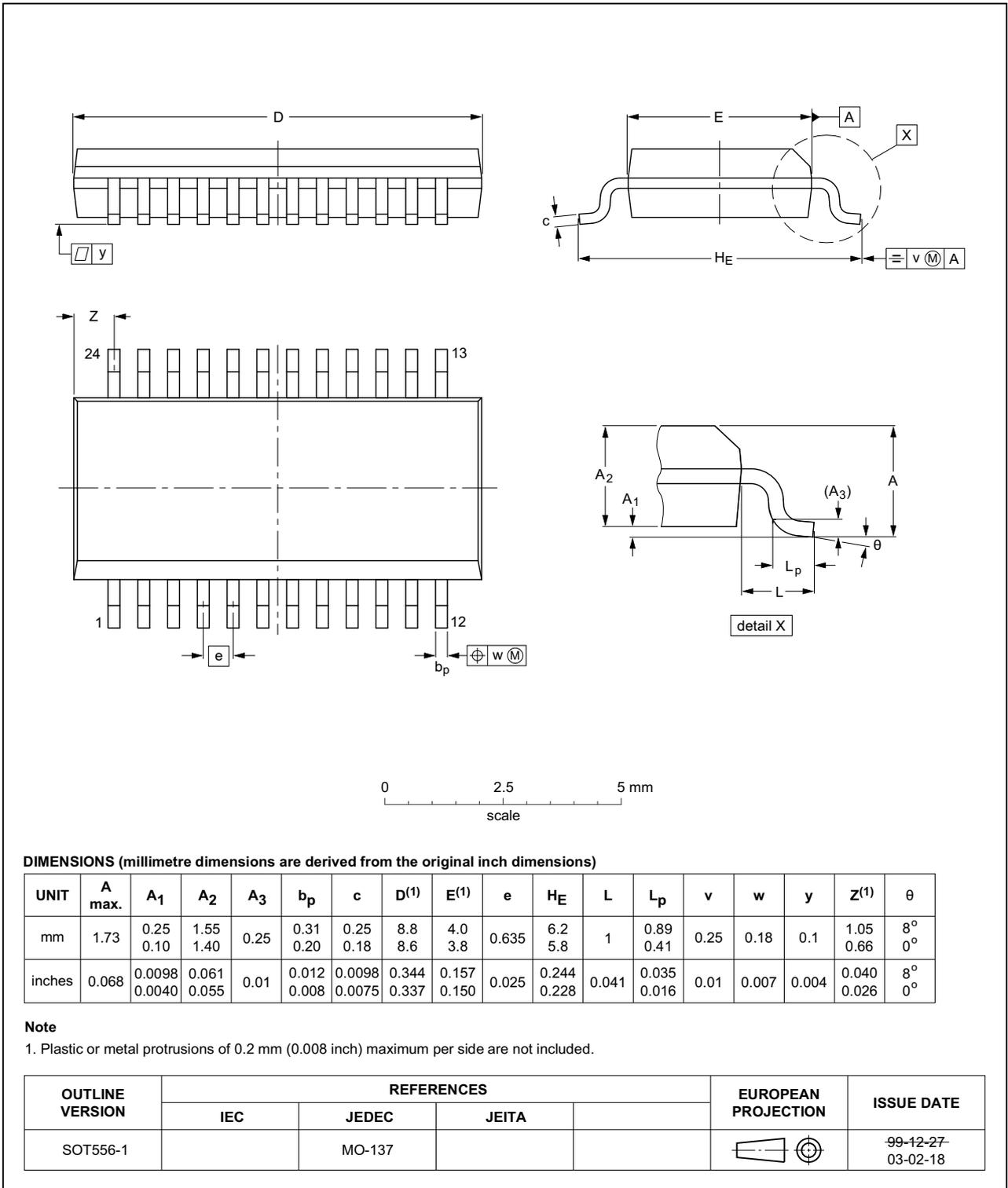


Fig 19. Package outline SOT556-1 (SSOP24)

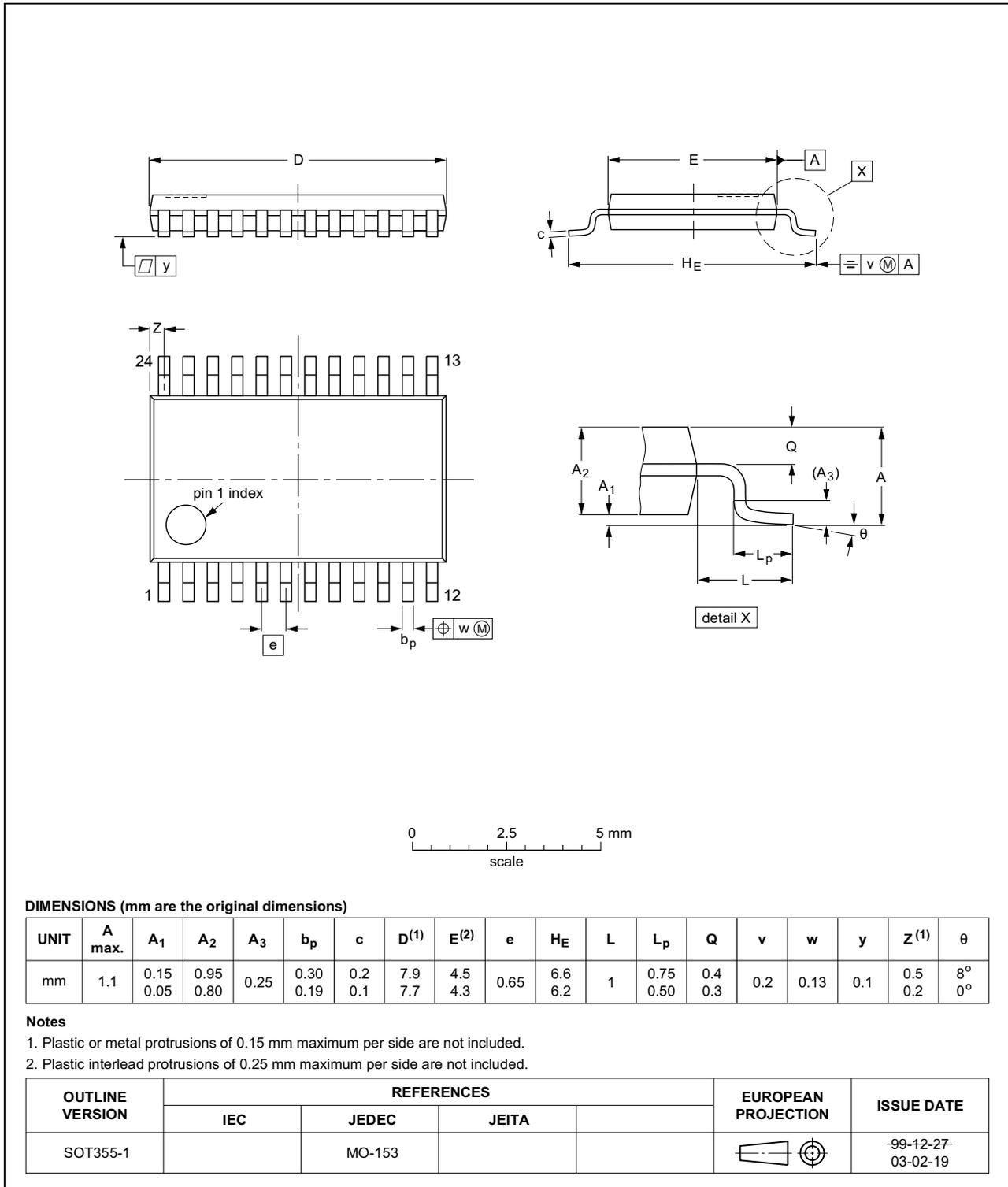


Fig 20. Package outline SOT355-1 (TSSOP24)

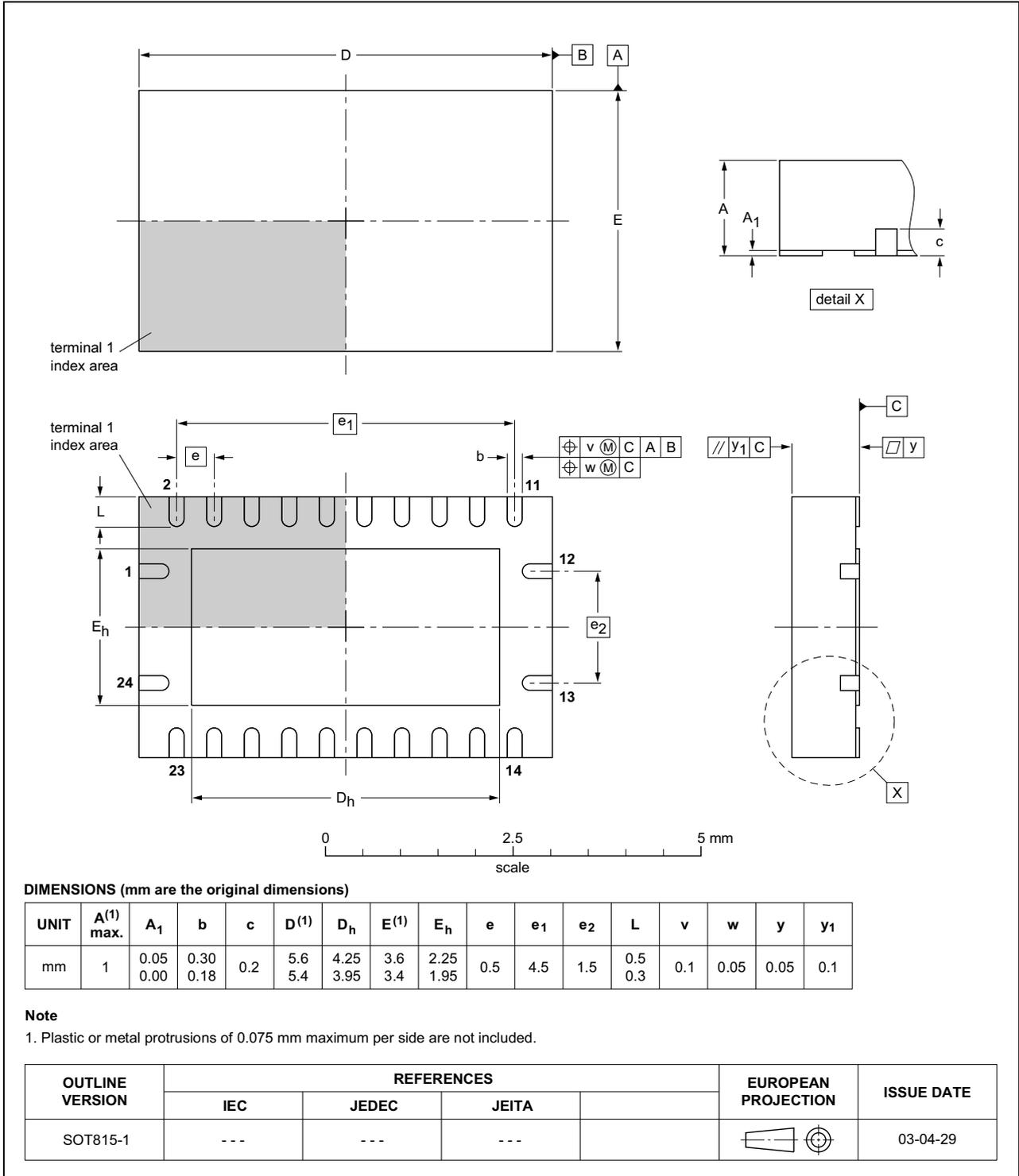


Fig 21. Package outline SOT815-1 (DHVQFN24)
