The package of the TLMY3102 is the P–LCC–2 (equivalent to a size B tantalum capacitor). It consists of a lead frame which is surrounded with


a white thermoplast. The reflector inside this package is filled up with clear epoxy.




Figure 1 Power Dissipation vs. Ambient Temperature




Figure 2 Forward Current vs. Ambient Temperature





Figure 3 Forward Current vs. Pulse Length




Figure 5 Forward Current vs. Forward Voltage




Figure 8 Relative Luminous Intensity vs. Forward Current





Figure 9 Relative Luminous Intensity vs. Wavelength



Ozone Depleting Substances Policy Statement

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
