




Figure 1 Power Dissipation vs. Ambient Temperature




Figure 2 Forward Current vs. Ambient Temperature




Figure 3 Rel. Luminous Intensity vs. Angular Displacement




Figure 4 Forward Current vs. Forward Voltage




Figure 5 Rel. Luminous Intensity vs. Ambient Temperature




Figure 6 Luminous Intensity vs. Forward Current





Figure 7 Relative Luminous Intensity vs. Wavelength










Ozone Depleting Substances Policy Statement
