## About your ThinkPad Hard Disk Drive

This section provides information on handling and replacing your ThinkPad Hard Disk Drive.

---

### Handling the hard disk drive

To protect your hard disk drive, observe the following precautions:

- Keep the drive in its static-protective bag until you are ready to install the drive in your ThinkPad computer. If you must put the drive down, place the static-protective bag on a flat, padded surface, and place the drive on the bag with the component side facing up.
- Handle the drive with care. Dropping or jarring the drive can damage the components inside the drive housing.
- Limit your movement. Movement can cause static electricity buildup.
- Do not subject the drive to physical shocks.
- Handle the drive by the edges.
- Do not touch any exposed components on the drive.
- Do not apply pressure to the cover of the drive.

**Attention:**

The drive is very sensitive. Incorrect handling can cause damage and permanent loss of data on the hard disk. Before removing the hard disk drive, make a backup copy of all the information on the hard disk, and then turn the computer off. Never remove the drive while the system is operating, in standby mode, or in hibernation mode.

---

### Replacing the hard disk drive

Replace the hard disk drive only if you upgrade it or have it repaired. The connectors and bay of the hard disk drive were not designed for frequent changes or drive swapping.

**Note:** The following procedure may vary depending on the model of your ThinkPad computer. For more detailed instructions, refer to your system documentation.

To replace the hard disk drive, complete the following procedure:

1. Turn off your ThinkPad computer.
2. Disconnect the ac adapter and all cables from the computer.

3. Close the display and turn the computer over.
4. Remove the battery.
5. Remove the screw that secures the hard disk drive.
6. Remove the hard disk drive by pulling the cover away from the computer.
7. Remove the cover of the hard disk drive.
8. Unpack the new hard disk drive.

**Attention**

Before you unpack the hard disk drive, be sure to read "Handling the hard disk drive" on page 1-1.

9. Attach the cover to the new hard disk drive.
10. Insert the hard disk drive and its cover into the hard disk drive bay; then firmly install them. Make sure the label on the hard disk drive is facing the top of the computer.
11. Reinstall the screw.

**Note:** You can replace the screw with a security screw to prevent the hard disk drive from being easily removed. The security screw may not be included in your ship group. However, you can purchase screws directly from NABS at [www.nabsnet.com](http://www.nabsnet.com).

12. Reinstall the battery.
13. Connect the ac adapter and cables to the computer.

## Sobre a Unidade de Disco Rígido do ThinkPad

Esta seção fornece informações sobre o manuseio e a substituição da Unidade de Disco Rígido do ThinkPad.

---

### Manuseando a Unidade de Disco Rígido

Para proteger a unidade de disco rígido, observe as seguintes precauções:

- Mantenha a unidade em sua embalagem protetora antiestática até o momento da instalação da unidade no computador ThinkPad. Se você precisar abaixar a unidade, coloque a embalagem protetora antiestática sobre uma superfície plana e revestida e coloque a unidade sobre a embalagem com o lado do componente voltado para cima.
- Manuseie a unidade com cuidado. Derrubar ou sacudir a unidade pode danificar os componentes dentro de seu compartimento.
- Limite seus movimentos. Eles podem causar acúmulo de eletricidade estática.
- Não submeta a unidade a choques físicos.
- Manuseie a unidade pelas bordas.
- Não encoste em nenhum componente exposto da unidade.
- Não faça pressão na tampa da unidade.

#### **Atenção:**

A unidade é muito sensível. O manuseio incorreto pode causar danos e perda permanente de dados no disco rígido. Antes de remover a unidade de disco rígido, faça backup de todas as informações do disco rígido e, em seguida, desligue o computador. Nunca remova a unidade enquanto o sistema estiver operando, em modo de espera ou modo de hibernação.

---

### Substituindo a Unidade de Disco Rígido

Somente substitua a unidade de disco rígido para fazer o upgrade ou para consertá-la. Os conectores e o compartimento da unidade de disco rígido não foram projetados para alterações freqüentes ou troca de unidade.

**Nota:** O procedimento a seguir pode variar, dependendo do modelo do seu computador ThinkPad. Para obter instruções mais detalhadas, consulte a documentação do sistema.

Para substituir a unidade de disco rígido, conclua o seguinte procedimento:

1. Desligue o computador ThinkPad.
2. Desconecte o adaptador ac e todos os cabos do computador.
3. Feche a tampa (visor) do computador e vire-o.
4. Remova a bateria.
5. Remova o parafuso que prende a unidade de disco rígido.
6. Remova a unidade de disco rígido, puxando a tampa para fora do computador.
7. Remova a tampa da unidade de disco rígido.
8. Retire a nova unidade de disco rígido da embalagem.

**Atenção**

Antes de retirar a unidade de disco rígido da embalagem, certifique-se de ter lido “Manuseando a Unidade de Disco Rígido” na página 1-3.

9. Anexe a tampa à nova unidade de disco rígido.
10. Insira a unidade de disco rígido e a tampa no compartimento da unidade de disco rígido e instale-os com firmeza. Certifique-se de que a etiqueta na unidade de disco rígido está virada para cima no computador.
11. Reinstale o parafuso.

**Nota:** Você pode substituir o parafuso com um parafuso de segurança para evitar que a unidade de disco rígido seja facilmente removida. O parafuso de segurança pode não estar incluído no seu grupo de envio. No entanto, você pode comprar parafusos diretamente da NABS no endereço [www.nabsnet.com](http://www.nabsnet.com).

12. Instale novamente a bateria.
13. Conecte o adaptador ac e os cabos ao computador.

## Jednotka pevného disku ThinkPad

Tato část obsahuje informace o zacházení s jednotkou pevného disku a její výměně.

---

### Zacházení s jednotkou pevného disku

Abyste jednotku pevného disku nepoškodili, dodržujte následující pokyny:

- Ponechejte jednotku v antistatickém obalu, dokud ji nebudete instalovat do počítače ThinkPad. Potřebujete-li jednotku odložit, položte antistatický obal na plochý polstrovaný povrch a jednotku položte na obal stranou se součástkami nahoru.
- Zacházejte s jednotkou opatrně. Pád jednotky nebo prudký náraz může poškodit součástky uvnitř jednotky.
- Omezte svůj pohyb. Pohyb může vytvářet elektrostatický náboj.
- Nevystavujte jednotku fyzickým šokům.
- Jednotku berte za okraje.
- Nedotýkejte se nezakrytých součástí jednotky.
- Netlačte na povrch jednotky.

#### **Upozornění:**

Jednotka je velmi citlivá. Nesprávné zacházení může způsobit poškození a trvalou ztrátu dat na pevném disku. Před vyjmutím jednotky pevného disku zálohujte všechna data na pevném disku a pak počítač vypněte. Jednotku pevného disku nikdy nevyjímajte, pokud je počítač v provozu, v pohotovostním režimu nebo režimu spánku.

---

### Výměna jednotky pevného disku

Jednotku pevného disku vyměňte pouze tehdy, pokud provádíte upgrade, nebo při opravě jednotky. Konektory a pozice jednotky pevného disku nebyly navrženy pro časté výměny disku.

**Poznámka:** Uvedený postup se může lišit podle modelu vašeho počítače ThinkPad. Podrobné instrukce naleznete v dokumentaci k vašemu systému.

Jednotku pevného disku vyměníte následujícím postupem:

1. Vypněte počítač ThinkPad.
2. Odpojte od počítače adaptér napájení a všechny kabely.
3. Zavřete displej počítače a počítač otočte.
4. Vyjměte baterii.

5. Vyšroubujte šroub, který zajišťuje jednotku pevného disku.
6. Vytáhněte jednotku pevného disku tahem za kryt směrem od počítače.
7. Oddělte kryt od jednotky pevného disku.
8. Vybalete novou jednotku pevného disku.

#### **Upozornění**

Před vybalením jednotky si přečtěte část “Zacházení s jednotkou pevného disku” na stránce 1-5.

9. Kryt přiřadíte k nové jednotce pevného disku.
10. Vložte jednotku pevného disku a její kryt do pozice jednotky pevného disku, pak je pevně namontujte. Ověřte, že je štítek na jednotce pevného disku otočen směrem k horní části počítače.
11. Šroub našroubujte zpět.

**Poznámka:** Šroub lze nahradit bezpečnostním šroubem, který znemožňuje snadné vyjmutí jednotky pevného disku. Bezpečnostní šroub nemusí být obsažen ve vaší dodávce. Tento šroub lze však objednat u firmy NABS na webové stránce [www.nabsnet.com](http://www.nabsnet.com).

12. Vložte zpět baterii.
13. Připojte k počítači adaptér napájení a kabely.

## A propos de votre unité de disque dur ThinkPad

La présente section fournit des informations sur la manipulation et le remplacement de l'unité de disque dur ThinkPad.

---

### Manipulation de l'unité de disque dur

Pour protéger l'unité de disque dur, observez les précautions suivantes :

- Laissez l'unité dans son emballage antistatique jusqu'à ce que vous soyez prêt à l'installer dans l'ordinateur ThinkPad. Si vous devez poser l'unité, placez l'emballage antistatique sur une surface plane rembourrée et posez l'unité sur l'emballage, côté composants vers le haut.
- Manipulez l'unité avec précaution. Si vous la laissez tomber ou si vous la cognez, vous risquez d'endommager ses composants internes.
- Limitez vos mouvements. Les mouvements contribuent en effet à générer de l'électricité statique.
- Evitez de faire subir des chocs physiques à l'unité.
- Manipulez l'unité en la tenant par ses bords.
- Ne touchez pas les composants exposés de l'unité.
- N'exercez aucune pression sur le cache de l'unité.

#### **Attention :**

L'unité est extrêmement sensible. Toute manipulation incorrecte risque d'entraîner des dommages et la perte permanente des données stockées sur le disque dur. Avant de retirer l'unité de disque dur, faites une copie de sauvegarde de toutes les informations stockées sur le disque dur, puis mettez l'ordinateur hors tension. Ne retirez jamais l'unité pendant que le système est actif, en mode veille ou en mode hibernation.

---

### Remplacement de l'unité de disque dur

Ne remplacez l'unité de disque dur que si vous effectuez une mise à niveau ou si vous devez la faire réparer. Les connecteurs et la baie de l'unité de disque dur n'ont pas été conçus pour des changements fréquents ou pour des échanges d'unité.

**Remarque :** La procédure suivante peut varier en fonction du modèle d'ordinateur ThinkPad. Pour obtenir des instructions plus détaillées, reportez-vous à la documentation fournie avec votre système.

Pour remplacer l'unité de disque dur, procédez comme suit :

1. Mettez l'ordinateur ThinkPad hors tension.
2. Débranchez le boîtier d'alimentation et tous les câbles de l'ordinateur.
3. Fermez l'écran et retournez l'ordinateur.
4. Retirez la batterie.
5. Retirez la vis qui permet de fixer l'unité de disque dur.
6. Retirez l'unité de disque dur en tirant sur le cache pour le sortir de l'ordinateur.
7. Retirez le cache de l'unité de disque dur.
8. Déballez la nouvelle unité de disque dur.

**Attention**

Avant de déballez l'unité de disque dur, lisez attentivement la section «Manipulation de l'unité de disque dur» à la page 1-7.

9. Fixez le cache sur la nouvelle unité de disque dur.
10. Insérez l'unité de disque dur et son cache dans la baie d'unité de disque dur, puis installez-les correctement. Vérifiez que l'étiquette apposée sur l'unité de disque dur est orientée vers le haut de l'ordinateur.
11. Réinstallez la vis.

**Remarque :** Vous pouvez remplacer la vis par une vis de sécurité pour que l'unité de disque dur ne puisse pas être retirée facilement. La vis de sécurité peut ne pas être incluse dans les accessoires livrés. Vous pouvez néanmoins vous en procurer une directement auprès de NABS, à l'adresse [www.nabsnet.com](http://www.nabsnet.com).

12. Réinstallez la batterie.
13. Rebranchez le boîtier d'alimentation et les câbles sur l'ordinateur.

## Produktinformation zum ThinkPad-Festplattenlaufwerk

Dieser Abschnitt enthält Informationen zur Behandlung und zum Austausch des ThinkPad-Festplattenlaufwerks.

---

### Behandlung des Festplattenlaufwerks

Beachten Sie die folgenden Vorsichtsmaßnahmen, um das Festplattenlaufwerk zu schützen:

- Bewahren Sie das Laufwerk in der antistatischen Schutzhülle auf, bis Sie es im ThinkPad installieren. Wenn Sie das Laufwerk absetzen müssen, legen Sie die antistatische Schutzhülle auf eine ebene, gepolsterte Oberfläche, und setzen Sie das Laufwerk auf der Schutzhülle mit der Seite der Komponente nach oben ab.
- Behandeln Sie das Laufwerk vorsichtig. Wenn Sie das Laufwerk fallen lassen oder damit anstoßen, können Komponenten innerhalb des Laufwerkgehäuses beschädigt werden.
- Reduzieren Sie Ihre Bewegungen. Durch Bewegung kann sich das Laufwerk statisch aufladen.
- Setzen Sie das Laufwerk keinen physischen Erschütterungen aus.
- Fassen Sie das Laufwerk an den Rändern an.
- Berühren Sie keine ungeschützten Komponenten im Laufwerk.
- Drücken Sie nicht auf die Abdeckung des Laufwerks.

#### **Achtung:**

Das Laufwerk ist sehr empfindlich. Durch unsachgemäße Behandlung können Beschädigungen und dauerhafter Datenverlust auf der Festplatte verursacht werden. Erstellen Sie vor dem Entfernen des Festplattenlaufwerks eine Sicherungskopie aller Daten auf der Festplatte, und schalten Sie dann den Computer aus. Entfernen Sie das Laufwerk nie in laufendem Betrieb, im Bereitschaftsmodus oder im Hibernationsmodus.

---

### Festplattenlaufwerk austauschen

Tauschen Sie das Festplattenlaufwerk nur aus, wenn Sie einen Upgrade ausführen möchten oder wenn das Laufwerk repariert werden muss. Die Anschlüsse und die Position des Festplattenlaufwerks sind nicht für häufige Änderungen oder für häufiges Austauschen des Laufwerks ausgerichtet.

**Anmerkung:** Die folgende Vorgehensweise hängt von Ihrem ThinkPad-Modell ab. Ausführlichere Anweisungen können Sie der Dokumentation zum System entnehmen.

Gehen Sie wie folgt vor, um das Festplattenlaufwerk auszutauschen:

1. Schalten Sie den ThinkPad aus.
2. Trennen Sie das Netzteil und alle Kabel vom Computer.
3. Schließen Sie die Anzeige, und drehen Sie den Computer um.
4. Entnehmen Sie den Akku.
5. Entfernen Sie die Schraube, mit der das Festplattenlaufwerk befestigt ist.
6. Entfernen Sie das Festplattenlaufwerk, indem Sie die Abdeckung vom Computer wegziehen.
7. Entfernen Sie die Abdeckung vom Festplattenlaufwerk.
8. Entnehmen Sie das neue Festplattenlaufwerk aus der Verpackung.

**Achtung**

Lesen Sie Abschnitt „Behandlung des Festplattenlaufwerks“ auf Seite 1-9, bevor Sie das Festplattenlaufwerk aus der Verpackung entnehmen.

9. Bringen Sie die Abdeckung am neuen Festplattenlaufwerk an.
10. Setzen Sie das Festplattenlaufwerk und die Abdeckung in die Position für das Festplattenlaufwerk ein; befestigen Sie anschließend das Laufwerk und die Abdeckung. Das Etikett am Festplattenlaufwerk muss nach der Oberseite des Computers gerichtet sein.
11. Bringen Sie die Schraube wieder an.

**Anmerkung:** Sie können an Stelle der Schraube eine Sicherheitsschraube verwenden, um zu verhindern, dass das Festplattenlaufwerk auf einfache Weise entfernt werden kann. Die Sicherheitsschraube ist möglicherweise nicht in Ihrer Liefergruppe enthalten. Sie können Schrauben jedoch direkt von NABS unter der Adresse [www.nabsnet.com](http://www.nabsnet.com) bestellen.

12. Setzen Sie den Akku wieder ein.
13. Schließen Sie das Netzteil und die Kabel wieder am Computer an.

## Informazioni sull'unità disco fisso ThinkPad

In questa sezione vengono fornite le informazioni sull'utilizzo e sulla sostituzione dell'unità disco fisso ThinkPad.

---

### Utilizzo dell'unità disco fisso

Per proteggere l'unità disco fisso, osservare le seguenti precauzioni:

- Conservare l'unità in un imballo antistatico fino a quando non si è pronti per effettuare l'installazione dell'unità sul computer ThinkPad. Per poggiare l'unità, posizionare l'imballo antistatico su una superficie piana e posizionare l'unità sull'imballo.
- Maneggiare l'unità con cura. Il trasporto o la caduta dell'unità può danneggiare i componenti interni.
- Limitare i movimenti. Il movimento può generare elettricità statica.
- Non sottoporre l'unità a urti.
- Afferrare l'unità dalle estremità.
- Non toccare gli altri componenti esposti sull'unità.
- Non esercitare pressione sul coperchio dell'unità.

#### **Attenzione:**

L'unità è molto sensibile. Eventuali danni potrebbero provocare la perdita permanente dei dati sul disco fisso. Prima di rimuovere l'unità disco fisso, eseguire una copia di backup di tutte le informazioni sul disco fisso e spegnere il computer. Non rimuovere mai l'unità se il sistema è in esecuzione oppure in modalità standby o ibernazione.

---

### Sostituzione dell'unità disco fisso

Sostituire l'unità disco fisso solo per aggiornarla o ripararla. I connettori e il vano dell'unità disco fisso non sono stati progettati per sostituzioni frequenti dell'unità.

**Nota:** La seguente procedura può variare a seconda del modello di computer ThinkPad. Per istruzioni dettagliate, fare riferimento alla documentazione relativa al proprio sistema operativo.

Per sostituire l'unità disco fisso, completare la seguente procedura:

1. Spegnere il computer ThinkPad.
2. Scollegare l'adattatore CA e tutti i cavi dal computer.

3. Chiudere il video e capovolgere il computer.
4. Rimuovere la batteria.
5. Rimuovere la vite che fissa l'unità disco fisso.
6. Estrarre l'unità disco fisso dopo aver rimosso il coperchio dal computer.
7. Rimuovere il coperchio dell'unità disco fisso.
8. Disimballare la nuova unità disco fisso.

**Attenzione**

Prima di disimballare l'unità disco fisso, leggere le informazioni contenute nella sezione "Utilizzo dell'unità disco fisso" a pagina 1-11.

9. Fissare il coperchio sulla nuova unità disco fisso.
10. Inserire l'unità disco fisso con il coperchio nell'apposito vano, quindi installarla in modo sicuro. Verificare che l'etichetta dell'unità disco fisso sia rivolta verso l'alto.
11. Fissare la vite.

**Nota:** E' possibile utilizzare una vite di sicurezza per impedire che l'unità venga rimossa facilmente. La vite di sicurezza non è inclusa nel pacchetto. Ma, è possibile acquistarla direttamente sul sito NABS all'indirizzo [www.nabsnet.com](http://www.nabsnet.com).

12. Reinstallare la batteria.
13. Collegare l'adattatore CA e i cavi al computer.

## Acerca de la unidad de disco duro para ThinkPad

Este apartado proporciona información acerca de cómo manipular y sustituir la unidad de disco duro para ThinkPad.

---

### Manipulación de la unidad de disco duro

Para proteger la unidad de disco duro, tenga en cuenta estas precauciones:

- Conserve la unidad en la funda de protección contra electricidad estática hasta el momento de colocar la unidad en el sistema ThinkPad. Si necesita poner la unidad hacia abajo, coloque la funda de protección contra electricidad estática en una superficie lisa y blanda, y coloque la unidad de la funda con la cara de los componentes mirando hacia arriba.
- Manipule la unidad con cuidado. Una sacudida o caída de la unidad podría dañar los componentes internos alojados en la unidad.
- Limite el movimiento. El movimiento puede ocasionar una acumulación de electricidad estática.
- No exponga la unidad a choques físicos.
- Manipule la unidad por los extremos.
- No toque ninguno de los componentes de la unidad que quedan a la vista.
- No presione la cubierta de la unidad.

#### **Atención:**

La unidad es muy sensible. Una manipulación incorrecta podría dañar la unidad de disco duro y hacer que se perdieran datos de forma permanente de ella. Antes de extraer la unidad de disco duro, efectúe una copia de seguridad de toda la información del disco duro y, a continuación, apague el sistema. No extraiga nunca la unidad cuando el sistema está en funcionamiento, en modalidad en espera o en modalidad de hibernación.

---

### Sustitución de la unidad de disco duro

Sustituya la unidad de disco duro sólo si la actualiza o si la va a reparar. Los conectores y la bahía de la unidad de disco duro no se han diseñado para que se produzcan cambios frecuentes o intercambios de unidad.

**Nota:** El procedimiento siguiente puede variar en función del modelo de su sistema ThinkPad. Si desea instrucciones detalladas, consulte la documentación del sistema.

Para sustituir la unidad de disco duro, lleve a cabo el procedimiento siguiente:

1. Apague el sistema ThinkPad.
2. Desconecte el adaptador de CA y todos los cables del sistema.
3. Cierre la pantalla y apague el sistema.
4. Extraiga la batería.
5. Extraiga el tornillo que une la unidad de disco duro.
6. Extraiga la unidad de disco duro tirando de la cubierta y sacándola del sistema.
7. Extraiga la cubierta de la unidad de disco duro.
8. Desempaquete la unidad de disco duro nueva.

**Atención**

Antes de desempaquetar la unidad de disco duro, no olvide leer el apartado "Manipulación de la unidad de disco duro" en la página 1-13.

9. Coloque la cubierta en la unidad de disco duro nueva.
10. Coloque la unidad de disco duro y su cubierta en la bahía de la unidad de disco duro y, a continuación, encájela bien. Asegúrese de que la etiqueta de la unidad de disco duro está mirando hacia la parte superior del sistema.
11. Vuelva a atornillar el tornillo.

**Nota:** Puede sustituir el tornillo por un tornillo de seguridad para evitar que la unidad de disco duro se pueda extraer fácilmente. Puede que el tornillo de seguridad no esté incluido en el material suministrado. Sin embargo, puede adquirir tornillos directamente a NABS en [www.nabsnet.com](http://www.nabsnet.com).

12. Vuelva a colocar la batería.
13. Conecte el adaptador de CA y los cables al sistema.

## Informácie o jednotke pevného disku vášho počítača ThinkPad

**The IBM Warranty for Machines:** IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

**Extent of Warranty:** The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.**

**Items Not Covered by Warranty:** IBM does not warrant uninterrupted or error-free operation of a Machine. **Limitation of Liability:** Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM.
