




Fig.3 Static Drain-Source On-State Resistance vs. Drain Current




Fig.5 Static Drain-Source On-State Resistance vs. Drain Current




Fig.2 Typical Output Characteristics (${\rm I\!I}$)




Fig.4 Static Drain-Source On-State Resistance vs. Drain Current





Fig.6 Typical Transfer Characteristics





Fig.8 Static Drain-Source On-State Resistance vs. Gate-Source Voltage









Fig.11 Typical Capacitance vs. Drain-Source Voltage






Fig.10 Dynamic Input Characteristics





Fig.12 Normalized Transient Thermal Resistance v.s. Pulse Width




Fig.13 Maximum Safe Operating Area




Fig.1-1 Switching Time Measurement Circuit




Fig.2-1 Gate Charge Measurement Circuit




Fig.1-2 Switching Waveforms




Fig.2-2 Gate Charge Waveform
